In consideration of the sum of \$125.00 paid herewith, the above named Fair Association grants to the undersigned Exhibitor the privilege to erect and install on their fair grounds and in such space as may be assigned by the association the following:

- Exhibitor shall bear the cost of display space and its contents
  - Fair Association shall furnish the electric current without the cost to the Exhibitor
  - Fair Association shall also provide the permanent electrical installation
  - Fair Association shall provide reasonable help in preparing the display space
  - Free Exhibitor Passes into the fair grounds shall be issued.
  - The number of passes shall be determined by Management.

Said Exhibitor agrees to handle or display only such articles or devices as may be specified in this contract, and only upon the space and at the stand or space assigned to him/her, unless otherwise specified herein or permitted by the Association. The Exhibitor shall not at any time install, or operate, or carry on, directly or indirectly, either by himself or through his agents or employees, anything that is in violation of the law. No privilege or concession shall be considered "exclusive" unless so stipulated in this contract. Any authorized representative of the Association shall have free access at any time on the premises allotted to the Exhibitor. The Association shall have the right to resell the above-named space if the Exhibitor does not occupy same by the close of the first day of the Fair, and the Exhibitor shall forfeit deposit of any money paid to the Association for reservation of same. If at any time, in the opinion of the Fair Management, said Exhibitor of Exhibit is found to be detrimental to the interest of the Association, the Exhibitor shall remove said Exhibit from the fair grounds on demand, and at this or her or their own expense. For the violation of the terms of this contract, the Association shall have the right to declare same VOID and close the Exhibit without recourse. The Exhibition space shall be available to the Exhibitor during regular fair days and hours as may be announced from time to time. All terms, matters and conditions contained in the Annual Fair Booklet are incorporated herein by reference.

The Association shall not be liable to the Exhibitor for any loss, damage or injury which may be suffered, it being understood that the Exhibitor shall have redress only against the person or persons causing such damage or injury.
